ASSISTANCE ANIMAL REASONABLE ACCOMMODATION FORM INSTRUCTIONS

The Assistance Animal Reasonable Accommodation Request Form is intended to be used by Eligible Students who live or desire to live in University Housing and Eligible Students and Eligible Employees for themselves or their Eligible Dependents who live or desire to live in Family Housing (please see Assistance Animals in University Housing and Family Housing Regulation for all definitions of capitalized terms) and who need an Assistance Animal as a reasonable accommodation to afford an individual with a Documented Disability an equal opportunity to use and enjoy a University Housing or Family Housing Dwelling. Applicants for Assistance Animal Reasonable Accommodation must adhere to the following guidelines:

1. Have current documentation of the Eligible Student, Eligible Employee or Eligible Dependent's Documented Disability(ies) using guidelines stated within [DisDocuGuidelines.doc](#), registered and filed with the Office of Services for Individuals with Disabilities (OSID).
2. Provide to OSID Staff current documentation in support of the following items:
 - i) Information in support of the Documented Disability(ies) using guidelines stated within: [DisDocuGuidelines.doc](#)
 - ii) Information detailing the necessity of the animal to afford you, an individual with Documented Disability(ies), or an Eligible Dependent with Documented Disability(ies), an equal opportunity to use and enjoy the University Housing or Family Housing Dwelling
 - iii) Information detailing the identifiable relationship between the Documented Disability(ies) and the assistance the Assistance Animal provides
3. Provide to OSID Staff documentation of the Assistance Animal's appropriate vaccinations and licensing as required by state or local law.

Please attach to this form documentation and information in support of each of the items required under 2 and 3 above.

4. Eligible Students and Eligible Employees must complete the Assistance Animal Reasonable Accommodation form no later than **15 academic days before** (i) the Eligible Student or Eligible Employee or Eligible Dependent is scheduled to move into a University Housing or Family Housing Dwelling if not currently a resident or (ii) before the desired date for the Assistance Animal to move into the University Housing or Family Housing Dwelling. Academic days are those days University offices are open for business.

5. Please complete **Parts 1 – 2** of the Assistance Animal Reasonable Accommodation Form. Please see below. Incomplete applications will not be considered and will be sent back to applicant for completion. Please refer to the end of this form for details regarding submission of this form and supplemental documentation.

6. You must provide the original record of this completed form and applicable documentation to the OSID Staff. Please make copies of the Assistance Animal Reasonable Accommodation form for your own personal records.
